### Wind Farms in the Ochil Hills

20.01.07

Public Inquiries are currently being held into proposals for four Wind Farms to be built in the Ochil Hills. Perth & Kinross Council has already rejected these proposals with very strong support from many local residents and amenity groups – there have been nearly 1500 objections from the public. PKC and a group headed by Friends of the Ochils, supported by the Ramblers Association and FORK are lodging strong opposition to these developments at the Public Inquiries. We are all fully supportive of the need for renewable energy and the reduction of greenhouse gases but this must be done in an efficient way and effective way. Our objection is the impact these wind farms will have on an area of great natural beauty – within the hills and visually from significant distances over Kinross-shire and Fife. Apart from the turbines themselves, which some people find attractive, there is the permanent scarring on the landscape from the access roads and the visual impact of the pylons and transmission lines – these have been brushed aside as not directly relevant at the individual Public Inquiries. In a number of European countries large clusters of wind turbines have been located at ports and in industrial areas which mitigates the impact on the countryside but there is still a question mark over the efficacy in terms of contribution to reducing CO<sub>2</sub>

The much more important factor is that wind farms are a very inefficient means of generating electricity, largely because they only produce power on an intermittent basis – if the wind is too strong or below a certain threshold they cannot operate. In practice the overall output will be in the region of 30% of design capacity which is studiously omitted by most of the media and the power companies. Wind farms do not provide a reliable source of electricity and the supply network must continue to be dependent on conventional power stations for both industrial and domestic power. As of April last year, 88 wind farms were operational or approved in Scotland but there is no chance whatsoever of even the combined output leading to the closure of a single conventional power station. In fact the more wind farms the greater the need for back up from conventional power generation. So where is the benefit? It was admitted at one Public Inquiry that there would be no tangible effect on CO<sub>2</sub> reduction from individual wind farms. Wind farms are being heavily subsidised by public funds and the National Audit Office estimates that the cost of wind power is out of all proportion to the benefits to the consumer. The Advertising Standards Authority has also said that the benefit of wind farms is being significantly over stated. These are the unpalatable facts the UK Government does not want voiced because their case is that wind farms are making a positive contribution to the reduction in CO2 emission and thereby meeting their obligation under the Kyoto Agreement but in fact it is a purely cosmetic exercise. Over the next decade there will be an increased demand for electricity arising from growth in housing and from industry and commerce, so there will be an increased demand on the output from conventional power source just to keep pace with growth. As far as reducing CO2 emission is concerned there is little hope as it will all be swamped by increase in road usage and the expansion of air traffic.

Are we totally condemning wind generated electricity? No, a number of schemes are in already operating using wind turbines for sheltered housing, schools and industrial buildings but even these need to be assessed in cost effective terms. However, this is where the focus and the subsidy should be, as it will more likely reduce demand from the national grid and directly have a financial benefit to users, but this will require a major change from the power companies who at present do not want either cuts in use or input from private systems. There is however enormous potential for such schemes at sports centres, office blocks, factories, housing developments and even farms. Wind generation at the micro level, combined with greater use of solar power would lead to direct benefits in terms of reducing demand for hydrocarbon fuel and concurrently reducing CO<sub>2</sub> emission. This will be far more effective and much lower cost than subsidising industrial scale wind farms. Why then is the Scottish Executive prepared to follow the misguided policy of the UK Government and ruin vast tracts of the Scottish countryside when there are more effective, and lower cost, ways to achieve the goals we all seek? This is one of the key questions we should all be asking our MSPs and Local Councillors in the run up to the May elections.

Open Letter to Perth and Kinross Council 21.01.07 I am writing to ask your council to reconsider and explain their decision to sell Kinross Town Hall for residential purposes.

A lot has happened since your council's original decision in November 2002.

- 1. Many house building developments (some large) have been instigated or completed in southern and western Kinross. There are potentially many more in the pipeline e.g. the Auction Mart application.
- 2. The population of Kinross-shire is projected to grow by almost 25% to the year 2020.
- 3. You yourselves have identified the need for an area based initiative (ABI) for Kinross-shire which involves pursuing avenues assisting in infrastructure development as well as encouraging local employment and development through Tourism and Business.
- 4. You approved in 2003 a Document entitled: 'Towards a Sustainable Future'.
- 5. 2,400 Kinross residents indicated that they consider the Town Hall/Library should be 'retained by Perth & Kinross Council (PKC) and renovated and restored ...so as to provide facilities for the community."
- 6. Perth Concert Hall has been developed and built in Perth.
- 7. Perth City Hall has been subject to public consultation over its future use, a business plan developed and this is now being implemented.
- 8. Despite having a state of the art Community School the community of Auchterarder are requesting continued use of their own Town Hall.

I will deal with each point in turn.

- I have tried very hard to see the sense in providing residential accommodation in the Kinross town centre, but I can find none. There would appear to be ample residential building works going on in more appropriate locations.
- 2. The 25% projected rise in population in the next thirteen years needs some consideration. Even if the Community School proposed at Lethangie is adequate for that increase there will certainly be pressure on available space. Due to legal requirements for the provision of education being the primary use of the school, it would seem erroneous to rely on this new space being adequate to also provide for an expanding community's use.
- 3. It seems extremely logical that the future of the Town hall/Library building incorporate some of the ABI objectives. Tourism especially, seems extremely unlikely to flourish in a Town Centre which is predominantly residential. Visitors as well as Kinross-shire residents could positively benefit from rethinking the use for the current building.
- 4. I have reviewed your policy document, Towards a Sustainable Future and I can find no policy which

would support the current course of action. On the other hand, I can find several which contradict **t** (these are only two of those).

For example, Environment and Resources Policy 8 states: 'New development which would adversely affect listed building, conservation areas, scheduled ancient monuments... will not be permitted unless there is proven public interest where social economic and safety considerations outweighs the cultural interest in the site.'

Page 19 of that document refers to 'Protecting the role of town centres'.

Sustainable Communities Policy 8 states: 'Town centres will continue to be the main focus for investment in employment, retail, leisure and other service provision as they are accessible by all sectors of the community.... Development in ... town centres will be encouraged to improve their role and improve their vitality.'

- 5. I'm sure the Kinross residents would applaud all of the above policies. They seem eminently sensible to a sustainable community. They would also wonder why a lot of effort has obviously gone into producing such a policy document only for it, in this case, to be ignored.
- 6. The situation with the Concert Hall and City Hall in Perth shows that where there is political will, funds can be sourced, plans generated, instigated and publicly favourable outcomes implemented. I am not sure how accessible this project has been. I have not seen events there advertised in the Kinross Newsletter or on Kinross.cc, nor have I seen anything regarding the provision of transport for events held there.
- 7. There has been NO public consultation over the use of the Town Hall/Library building since all the above mentioned developments.
- 8. Enough said.

There are many possible uses of the Town Hall which would satisfy your own policies, these could include:

A Community Space - dedicated to community use in the town centre area.

A Youth Centre - Kinross is currently home to a large population of young people who DO NOT have any year round resource dedicated to their social needs.

A Business Centre - Something similar to the Alloa Business centre. Kinross needs employers, after all 56% of people travel more than 2km to work. It is also home to a rich human resource, both those being educated locally as well as many others who would have much to contribute to a thriving local and regional economy.

A Retail Centre - with a population projected to keep growing 25% every 20 years, such a use could prove beneficial in the longer term

A Cultural Centre – I would imagine visitors would be likely to visit a centre proximal to the natural and cultural heritage of Kinross as well as its retail centre. More likely than they would be to visit anything on a school site on the town periphery. Such a centre could incorporate many of the above suggestions.

All of the above would concur with Perth & Kinross Council 'Towards a Sustainable Future' policies as follows:

Sustainable Economy Policy 8

All new retail floor space will be directed to town centres

Sustainable Economic Policy 9

Local plans will encourage the sustainable development of the tourist industry in P & K and support proposals which:

Improve the quality of facilities

Offer the potential for providing local income and employment

Are suitable for resident as well as visitor use

Do not significantly damage the natural or built heritage

Once the Town Hall building is gone, it is gone. It is a space which, if properly planned and used, could be hugely beneficial to the development of Kinross as well as providing much needed infrastructure for a fast expanding community.

I would urge you to reconsider your decision.

### Save NHS Dentistry Campaign

It's almost a year since one of our Kinross dentists closed her doors to many NHS patients, which prompted some residents in Kinross to form the campaign to "Save NHS Dentistry" locally and across Scotland.

We have met regularly most months since then, collected 1200 signatures and lodged an e-petition with the Scottish Parliament which gained a further 144 names. We know it's a generalised problem but there is still a great amount of local concern. We took our petition to the Parliament's Petitions Committee in December and got press and media coverage in the Aberdeen Press & Journal and the Perthshire Advertiser (Friday 15/12/06); whilst Sheila Green and Felicity Garvie spoke to Radio Tay about the issues. The Petitions Committee will revisit our petition in the new year. When it does, local MSP Bruce Crawford has agreed to come with us and speak on our behalf. We don't expect things to change over night, but we are determined not to let up on this because we don't want to see any further privatisation of health and dental services.

Some of us also have specific problems such as not being able to get children registered with an NHS dentist or not being accepted onto NHS dentists' lists in other regions such as Fife. Longer term we are hoping that the new health centre will be able to accommodate dental facilities to cover the local need; or that at least a mobile dentist can be persuaded to visit Kinross to service those who currently aren't able to register with an NHS dentist.

Our next meeting is on **Wednesday 14 February** (sorry, not very romantic!) at Kinross Church Centre at 7 pm. We welcome any newcomers and thank all those who gave their time and energy to keep the campaign going throughout 2006. And we promise not to get any less vocal in 2007, particularly as there are elections coming up...! Felicity Garvie



### Drawing from Life

Over the last few months, local residents have been discovering their creative skills at Life Drawing classes in Millbridge Hall. The course has proved popular with residents of varying ages and interests. For some participants this is a chance to have a go at something new, while others are working on professional portfolios. This creates a healthy mix within the group, where participants can learn from each other under the direction of tutor John Strachan. John is a graduate from Kingston College of Art and Design and worked for many years in London as a general designer as well as teaching in various colleges around Britain. Although now retired, John still teaches drawing and painting, part time, through the University of St. Andrews, Madras College in St. Andrews and The Steeple Arts Centre in Newburgh, Fife. John describes the course as follows:

"Seeing is a different process to looking. Looking is for survival. Seeing involves different perceptions, including order, beauty, balance, quality of relationship and subtlety.

"Over the weeks, working from both male and female models, the course has covered the basic principles of drawing from life. Students have been introduced to a range of drawing materials and techniques, from quick animated sketches to long poses.

"If you can learn to draw the figure well, which is difficult, you will be able to draw most things. I believe life drawing is an invaluable way of increasing ones sensitivity, sense of proportion and perspective and of course, ones drawing ability."

# Credit Unions – once one of Scotland's best kept secrets, but not anymore!

Credit unions are financial co-operatives, owned and managed by their members. They are regulated by the FSA in the same way as all the other major providers are. This assures members of financial security, as their deposits are covered by the government-run Financial Services Compensation Scheme.

Kinross-shire is surrounded by successful Credit Unions but doesn't have a Credit Union of its own. Clackmannanshire; Kelty; Benarty and North East Fife are all covered by community based credit unions.

Scotland has 130 credit unions with about 200,000 members and assets of £300m. There are nearly 100,000 members of credit unions in Glasgow alone - that's about 14% of the population.

It is accepted that about 20% of the adult population are denied banking services and have to seek alternative sources for their borrowing. The home credit industry, known more commonly as doorstep lending, strategically targets the financially excluded and charges a minimum interest rate of 177% on small loans. Typically, a loan of £300 repaid over 55 weeks will require a total repayment of £477.

Credit unions are now the first choice for financial services for a growing number of people across Scotland. The most recent figures from the Financial Services Authority to June 2006 show that there are 529 credit unions in the UK with approximately £500m in assets.

Scottish credit unions generally pay an annual dividend on savings of between 2% and 5%. Borrowing is very affordable from a credit union at a monthly rate of 1% on the outstanding loan balance. That's an APR of 12.68%, which compares favourably with rates on credit and store cards which often charge 15% to 30%, particularly if you are on a low income. Credit unions are primarily thrift organisations which encourage members to take control of their own finances, both as borrowers and savers. Through the repayment history that they establish, members create a borrowing environment where loans, based on the capacity to repay, are generally granted on demand. They are assured too that credit union revenue will remain in their community for the common good.

# Upgrade your computing skills for as little as £10!

£100 towards computer training.

Courses which qualify for this funding include Information Technology 1 and 2. These will give you a firm grounding in all aspects of computing. Using Microsoft Office software, you'll gain a good working knowledge of word-processing, spreadsheet, database and presentation packages for home or office use.

There is also the option to work towards the European Computer Driving Licence (ECDL), a must for your CV! It's designed to cover key concepts in computing including, Basic Concepts of IT; File Management; Word Processing; Spreadsheets; Databases, Presentation and the Internet and is now being asked for by employers recruiting new staff.

### News from the Health Centre

There have been some recent changes in the way the appointment system at the Health Centre operates. St Serf's Medical Practice participated in the Advanced Access system for two years, but comments in the Patient Satisfaction Survey indicated that some aspects of the system could be improved. We have therefore reviewed the appointment system for both practices and decided to expand the triage system. members of our experienced nursing team will now speak to the majority of patients who request a same day appointment. They will ask patients for information about their condition to ascertain the nature and urgency of the condition. They will then offer the patient the most appropriate appointment. The appointment will always be on the same day if the condition requires immediate attention. Patients with non-urgent conditions will generally be offered appointments for another day. The appointment may be in the Minor Illness Clinics run by the senior nurses, as they can deal with many conditions previously dealt with by the doctors. Those who wish to pre-book appointments may do so, though we would ask you not to book more than 4 weeks in advance. We hope that these changes will ensure an appropriate balance of appointments both for those who have urgent conditions and those who wish to pre-book their appointment.

Each month this year, we will focus on a different health promotion topic. February's topic is the health of Young People and there is a display in the waiting room with relevant posters and leaflets. If you have suggestions for topics, then do contact the Practice Manager at the Health Centre.

### Loch Leven Heritage Project

Short days, gales and floods are not TRACKS ideal conditions for path construction, nevertheless work on The Rarol Access Committee of Kin the Loch Leven Heritage Project



trail around the loch has continued during December and January. The first phase of the TRACKS project, due for completion by the end of April 2007, will run from Kinross around the north shore to the Pow Burn. The ground has been very waterlogged in the Kinross area, so the contractors J M Dewar have focussed on the far end of the phase one section, near the Pow Burn. The Pow Burn drains into Loch Leven in the northeast, below Channel Farm – home of Scotland's

John Dewar explained how the team is coping: "We started before Christmas near Kinross House, but the loch was so high that the water was back to where we needed to work. So we moved our equipment round to the Pow Burn and have built about 700m of new path towards Burleigh Sands, as far as the old cemetery.

"Now we've moved to Burleigh Sands in order to work eastwards to join up with the path by the cemetery. The weather has been atrocious, so it has been rather stop-start, but we expect to have this phase finished on time."

The architectural firm RMJM has just completed the interpretation study. Their recommendations as to how to interpret the natural and human history of the area are now being considered by the project steering group. Their report includes ideas about what type of artworks and interpretation panels would be most appealing and educational for people using the trail.

There is good news for all who hope that the planned 13.5km trail can be extended all the way round the loch to complete the circle. Perth and Kinross Council has awarded TRACKS £10,000 to do a feasibility study into a route from Vane Farm to Kinross. This proved the most problematic area when the Loch Leven Heritage Project was being developed. The decision was taken to leave it out of the project and to tackle the major part of the circuit where agreement could be reached - from Kinross clockwise to Vane Farm.

The TRACKS committee has appointed Peter Scott to undertake the Feasibility Study and he is now in the middle of the work. Of course, if a route can be agreed to complete the link, TRACKS will have to seek extra funding to do the work on top of the existing project. Other activity related to, but additional to the Loch Leven Heritage Project, concerns the need to expand the Burleigh Sands car park, which will become even more popular once the project is completed and more people visit to use the path. TRACKS has been discussing this with Scottish Natural Heritage and the landowner, Kinross Estates, with a view to submitting a planning application to Perth and Kinross Council.

So, despite the weather, work is proceeding behind the scenes to deliver the project and to look at potential enhancements. This is an exciting time for TRACKS, as their vision of enabling many more people to enjoy Kinross-shire's greatest natural feature gradually takes shape.

### Charity Cycle Event at Kinross House

Dozens of youngsters from local playgroups and nurseries are set to take part in a sponsored cycle around the gardens of Kinross House to raise funds for Cancer Research UK. The event will take place on Sunday 4 March and is being organised by Crook of Devon woman Julie Rose, who organised a similar event last year which raised £1,400 for the charity. Julie said, "last year 67 children took part, this year we are aiming to have at least 180 children. My two daughters attend Fossoway School and the school children are tremendous in supporting this event." She added, "special thanks go to Jamie Montgomery of Kinross House for permission to use the estate for a second year."

### Milnathort Flooding

An action group has been formed by some residents of Milnathort following dissatisfaction with P&KC's response to the flooding which occurred on 13 and 14 December.

At the time of writing, the Post Office, chip shop and Jolly Beggars are still closed, and several families are being housed in temporary accommodation following the deluge which occurred when local waterways burst their banks following days of exceptionally heavy rain. It appears that flood water also surcharged from the drainage system.



Questions are being asked as to why the flood defence works, completed in August 2006 at a cost of £500,000, failed to cope with the floodwater. Arup Scotland, who designed the flood alleviation scheme and supervised construction, sent staff to Milnathort on 14 December to examine the situation. A report is being prepared by Arup staff who were not involved in the original design.

Meanwhile, a report submitted to P&KC's Enterprise and Infrastructure Committee on 17 January by the Executive Director (Environment) has been criticised for inaccuracies. It lists just 17 commercial, industrial and domestic properties in Milnathort that had been affected. Parts of Kinross were also affected by the flooding. Anyone in Milnathort or Kinross whose property was affected and who thinks they have been "missed" by the Council is urged to make contact with P&KC.

### **Town Hall and Library**

Progress with the court case was depressingly slow last year, and we have not been able to write anything of substance for some time, so we briefly summarise below some earlier stages of this matter before reporting some developments.

### Background

A decision was taken at the Council's Strategic Policy and Resources Committee (SP&RC) in February 2002 to sell the Town Hall and Library. Local people claimed the Council did not have the right to sell the buildings as they had been donated to the local community in perpetuity, i.e. they were part of the common good. Because a question had arisen regarding P&KC's right to dispose of the buildings, P&KC was obliged under Section 75 of the Local Government (Scotland) Act 1973 to petition the Sheriff Court for permission to sell. They did this in August 2005. They had already found a purchaser offering £185,000. The Council proposed putting approximately £66,500 of this into the Kinross Common Good Fund, whilst retaining the remaining £118,500 (approx). The reasons for retaining this sum were: (1) although P&KC acknowledged that the Town Hall was common good, it felt the Library was not and (2) P&KC wanted to withhold a sum to cover maintenance costs expended over recent years on the buildings and the cost of setting up the portacabin library.

Kinross CC was accepted into the legal process in the Sheriff Court as respondent in the case. In January 2006 the Sheriff agreed to sist, or suspend, the court case while both sides jointly obtained the opinion of a QC on certain points of law. Both sides were to be bound by the QC's opinion. Due principally to staff changes at P&KC, the QC was not instructed until May, and his opinion not supplied until late August. In early September the CC's solicitor asked P&KC how they intended to proceed, and a formal response to this enquiry was not received until 1 December 2006.

Following receipt of the QC's opinion, fresh decisions relating to the court case were made at some P&KC Committees.

### Development 1

In November the Executive sub committee of the SP&RC resolved "That in relation to the court action regarding Kinross Town Hall and the Kinross Carnegie Free Library, the whole of the property be conceded to be part of the common good fund, and that the whole proceeds should be paid into the Kinross Common Good Fund without any deductions for historic maintenance costs."

### Development 2

On 20 December the Kinross Common Good Fund Committee was reconvened for the first time in many years. The remit of Common Good Fund Committees is to:

- determine all matters involving the disbursement of Common Good Fund monies
- determine all matters relating to property or land or other assets held by the Common Good Funds.

As there is only £596.12 in the fund there have been no surpluses worth disbursing to good causes in recent years. It would seem, however, that someone had remembered the second part of the remit. The Committee consisted of Local Councillors George Hayton (Kinross Town) and Willie Robertson (Milnathort and North Kinross), plus Jimmy Doig and Willie Wilson (Convener and Vice-Convener of the SP&RC). We do not know exactly what the Common Good Fund Committee was being asked to decide, as Council officers recommended that the report to the committee (by the Head of Property) should be excluded from the public and press under Schedule 7A of the Local Government (Scotland) Act 1973.

However, we thought the Common Good Fund Committee was probably being asked to approve the earlier decision of the SP&RC to sell the buildings. We applied to send a deputation. Eileen addressed the committee and also answered questions for ten minutes. We urged the committee to reconsider the Council's decision to sell. We reminded them that 2,400 of their local constituents had signed a petition stating their belief that the Town Hall and Library buildings were gifted to the local people and that the local authority had an obligation to restore and maintain them. We also argued that a compromise solution, whereby perhaps part of the buildings could be converted to commercial use (office or retail) whilst restoring the Town Hall for community use would be more beneficial to the town than converting all of the buildings to flats, which is the use they will be put to if the deal the Council hopes to conclude goes ahead. We had also submitted a six-page letter detailing these and many other points. The Committee's discussion took place in private. It seems our pleas were not successful: the Committee agreed to homologate (or ratify) the decision made by the SP&R Committee in 2002 to sell the buildings. We understand that the CGFC has also agreed that any maintenance costs as from 20 December 2006 should come from the Common Good Fund.

### The Next Step

Although the Council's new resolution (to put all proceeds into the Common Good Fund) is an improvement on the original petition, we still believe this is a woeful under-valuing of the buildings, due to years of neglect by the Council.

We expect P&KC to follow up their committee decisions with an amended petition to the Sheriff Court and for the case to resume. We will continue to oppose the sale of the buildings.

## **Police Box**

Festive Policing: We are happy to report that the holiday period passed with no more problems than we would normally encounter during any weekend in the year. However, there were two shop windows in Kinross High Street broken and several related incidents of graffiti whereby properties had "tags" spray-painted on them. In both cases persons were identified as being responsible and reports have been submitted to the Procurator Fiscal.

Parking on Pavements: Recently there have been complaints received at Kinross Police Office in connection with vehicles being parked on pavements. The main concerns are that pedestrians and other pavement users are having to negotiate a way around the obstruction and in some cases that means stepping onto the road. You will appreciate that this is not best practice for pedestrians who are young children or indeed persons pushing prams, due to traffic already on the road. This problem has arisen in most villages in the Kinross beat area. Where possible, Kinross officers will endeavour to respond to such complaints and deal with the matter accordingly. In some cases, persons have been reported to the Procurator Fiscal.

Visibility in the Dark: Some complaints have also been received in connection with non-vehicular road users who

are putting themselves (and others) in danger by not wearing adequate clothing,

which highlights their presence, on the roads. It is advisable for persons who jog, cycle or use horses on the roads, to wear clothing, where possible, which is fluorescent or reflective, during the hours of darkness. This will give any drivers of vehicles an indication of their presence on the road and hopefully avoid any collisions.



### **Probus Club**

There was a change of style for the December meeting. Instead of the usual speaker, the members were entertained by a concert party calling themselves "The



Third Generation" and consisting of four ladies. The Pianist was Eileen Atkinson, the Tap Dancer Lily Hutchison, the poetry recitations were given by Lucy Hunter and Katie Adamson, who describes herself as a singer, was the Leader of the group. The ladies stretch in age from 74 to 87 but despite their years are extremely active and gave a first class performance. The show consisted of three acts interspersed by poetry reading and a display of tap dancing. For the first act Lily, Lucy and Katie appeared as London costermongers dressed in the traditional style and sang a selection of songs all connected with London, starting with "Maybe it's because I'm a Londoner". The second act featured songs with an American theme, with the ladies dressed in costumes which had an American feel such as the stars and stripes while the third act centered round Christmas and the costumes were again on this theme. The two poems were the "The Kirk Mouse" and "Jenny and the Microwave", while Lily Hutchison gave a faultless display of tap dancing on a round board which had been the top of a table. Arthur Wallace gave the vote of thanks.

The speaker for the meeting on 3 January was Richard Hynd, and his subject, the Restoration of Vintage Cars. He divided vintage car enthusiasts into three groups, (1) Those who liked to own vintage cars and showed them at car rallies, (2) Those who liked to drive vintage cars - getting to know the inner working (3) Those who liked to restore vintage cars - Richard fell into this group.

Richard started over thirty years ago by acquiring an MG (TA series), which was in a ruinous state. Then he found a second MG which was rusting away in a garage. He went on to acquire four vintage cars, the two MGs already referred to, a 1927 flat-nosed Morris Oxford, and a 1926 bull-nosed Morris Cowley, He said it would be ten years at least before he is finished restoring this last car.

He then mentioned the great difficulty in obtaining spares. As can be imagined the dealers have stopped selling spares for these eighty-year-old cars long ago. But spares can still be found in the strangest of places, such as garage sales, from information on the internet and in magazines, car boot sales and in particular from the Autojumble Sale held in Beaulieu, a little place just south of Southampton. One of the most interesting sources of supply are a couple of firms who specialise in obtaining replica spares from the far East. These spares are absolutely identical to the genuine article but hand made in places like Taiwan.

The enthusiasts come from all walks of life, but all find vintage cars great fun and are united in a fellowship

with a great sense of camaradie. Malcolm Mason gave the vote of thanks.

At the meeting on 17 January, Bill Stark, a former President of the Dunfermline Probus Club entertained us with a fascinating series of slides taken on a visit to the Canadian Rockies. He started in Calgary with some very impressive pictures of the city and of the buildings erected for the Winter Olympics and showed us some of the arenas used for the Calgary Stampede and its Parade which were clearly quite a highlight of his visit. He then moved on through some quite barren areas of countryside with remarkable sculptures of limestone known as "hoodoos" formed by the action of wind and weather over the centuries to the city of Banff with its sulphur springs and caves and famous for the magnificent but expensive Banff Springs Hotel. He took us up the gondola lift to Sulphur Mountain where, even in July, there was still a good covering of snow and unfortunately also a lot of low cloud which rather spoiled the views.

We then moved to another Canadian Pacific Hotel, Chateau Lake Louise, beside the Lake and with a beautiful view of Mount Victoria, still snow covered, at the other end of the lake. He took us along the Bow River and showed us a selection of pictures of lakes of an incredible blue and often with beautiful reflections of the surrounding mountains and with forests of tall, lodge-pole pine trees and including some of the wild life of chipmunks and ground squirrels. mountainsides are very steep in places with trees clinging onto what seems to be almost bare rock and with waterfalls which appear out of the rock and sometimes disappear again into caves or tunnels. He then took us to the Athabasca Glacier and on to one of the special snow vehicles that are able to travel up the immense glacier that feeds the Athabasca River with melt water that finally arrives in the Atlantic Ocean far to the east. The final destination in the Rockies was Mount Robson, the highest peak in Canada.

Bill Stark then moved on to Vancouver and showed us some of the striking modern buildings in the city and the very beautiful flowers in the Queen Elizabeth Gardens including an amazing display of fuchsias and more beautiful gardens at Stanley Park with some resident skunks. After a short cruise along the coast from Vancouver they crossed to Vancouver Island and visited Victoria and the Butchart Gardens which occupy the site of a former quarry which has been transformed by the Butchart family into a magnificent garden and is now open to the public, again with a wonderful floral display including plants from around the world and also a number of statues. impossible to convey in words the beauty and magnificence of the scenery that Bill Stark showed us in his slides and a vote of thanks proposed by Jim King was warmly supported by the members.



### Kinross-shire Historical Society





from Dunfermline Heritage Society braved the elements to speak to members of the Kinross-shire Historical Society at their November monthly meeting. Her subject was "Malcolm, Margaret and Wallace" and she revealed encyclopaedic knowledge of Scottish history and over 40 years of research. With enthusiasm and humour she brought these 13th Century rulers to life, telling us that Queen Margaret wanted to be a nun, not a queen, that she brought Roman Catholicism to Scotland and that as the church became very wealthy the Dunfermline Monastery was the biggest and best. Twenty Kings and Queens were buried in Dunfermline. The audience, some 76 members and guests, would surely agree with Chairman Robin Eadie who said that he wished Mrs Pitcairn had taught him history.

It wasn't the sausage rolls and mince pies that lured the citizens of Kinross-shire to the December meeting. It was the speaker, Dr David Munro with his talk entitled "The Roads, Railways and Routeways of Kinross-shire." David speaks to audiences all over the world, so we are very privileged that he stays amongst us and observes and records this area, the landscape and the history.

David's talk was illustrated with marvellous slides of maps, old postcards, a watercolour painting and photographs ancient and modern. A map of West Fife by Blaeu in 1654 did not indicate any roads, but the existence of routeways can be found from other sources, including the first road improvement legislation passed in 1555 for the improvement of roads in and out of Scottish burghs. Tolls were raised as early as 1599 at Gaimeybridge and an act of 1699 advanced the building of roads and bridges using statute labour. The later Tumpike Acts passed during the late 18th and early 19th centuries established many of the roads we now use today.

By 1790, the Green Inn in Kinross was a well-known hostelry and from 1790 to 1848, the Inn and Kinross benefited from the heyday of the coaching era. The first train arrived in the county in March 1858 and Kinross subsequently became a railway junction as well as a road junction. In the 1890s, after the building of the Forth Bridge, a line was pushed through to Perth via Mawcarse and Glenfarg. The era of the railway came to an end in 1970 when the last train passed through the county.

David's talk brought us right up to the present day. TRACKS is now helping to change the landscape (and future maps) with the routeway around Loch Leven.

As Director of the Scottish Geographical Society, Dr Munro holds the same position as the famous explorer Sir Ernest Shackleton who was the Director 100 years ago. The Historical Society thanks David Munro most sincerely for finding time to talk to us again.

### Click Tips for February

It's definitely chilly outside, but what better excuse to get out and about than practising with your camera! People are often disappointed when they see their shots and they appear blurred and out-of-focus. But there's a few things you can do to help you get pin sharp shots

Firstly, think about the subject you're shooting. If it's an action shot, for example a sporting event, to capture the action you'll need to use a fast shutter speed. The faster the activity, the faster the shutter speed is a

general rule to follow. Using a faster film speed or upping the ISO rating on a digital camera to ISO 400, 800 or even more, will also help but be aware your pictures may appear a little more grainy as a result.

Think about how the camera is supported. If you're holding your camera by hand, make sure you won't shift off-balance. You don't need expensive tripods to keep the camera stable, look for a wall, a fence post or any other prop you can rest your camera on or against. A bean bag, or a bag full or rice, really helps to keep things stable.

Finally, once you mastered the art of getting things IN focus, why not try deliberately getting them OUT of focus! Make sure your camera is stable then slow down the shutter speed to capture running water in a sheer white veil.

Alternatively, why not try panning, which is an effective technique when photographing cars, sport, or other activities with lots of movement. Select a slow shutter speed, focus on your subject, as they move, follow them with the camera. This technique can be very effective as it blurs the background and creates a real sense of movement.





### **Farming**



### Black, White and Green

As most little boys love tractors will tell you; tractors nowadays are huge! Mechanisation of farming began after the Second World War and revolutionised agriculture. The nation was hungry after enduring food rationing and it was government policy to make sure that farmers could produce a plentiful supply of food in order that Britain become self sufficient. In much the same way as a computer revolutionised office practices, the tractor changed agriculture forever. Ploughing was made quicker and easier, plus the plough could turn over more soil. Breaking the ground down after ploughing was simple as the tractor could easily pull a harrow over the soil to create a perfect seedbed. Yields improved instantly and ever since, farmers have been perfecting the use of the tractor and its implements to improve yields, ease the workload and improve efficiency. These iron horses have grown larger over time and obviously consume a lot of energy but their influence has guaranteed the nation a plentiful supply of good food.

One thing that the inventors have not been able to mechanise yet is the humble farm dog. Just as our grandfathers and their grandfathers before them used a Collie dog to round up the sheep, all sheep farmers still rely on a dog for this kind of work. Sheep move quickly and no person or quad bike can nip from side to side as nimbly or as cleverly as a trained Collie. They are light on their feet and can reach sheep on steep ground easily. In this weather they are a blessing because they can move about the wet fields without trace. The sheepdog has many roles to play. Firstly they 'gather.' That is they are sent out from the gate of a field to gather up all the sheep and bring them together so that the whole batch are ready to be moved. Then they must 'drive.' This is the process of moving the sheep forward, keeping them together and headed in the right direction. A strong dog will also be able to 'force' the sheep through a gate or over a burn or into the sheep pens. At lambing time, the shepherd will rely on his Collie to assist in catching any ewe that needs help lambing. The dog will run alongside the ewe and slow it down until the shepherd gets a grip and catches the sheep. The dog does all this work quietly, without barking or using its teeth. Keeping the sheep as calm as possible is best for all concerned and a good sheepdog can do all these things and also be a good family friend.

In these days where we rely increasingly on technology and fossil fuel, the sheepdog represents the greenest, most environmentally sound workhorse on the farm. If you are lucky enough to get an opportunity to watch a sheepdog in action, it is both an amazing display of skill and a real kindness to our environment.



# **Community Council News**



### **Kinross Community Council**

### **News from the December Meeting**

Present at the meeting held on 6 December 2006 were: CCllrs D Colliar (Chair), D Cuthbert, R McConnell, C Drummond, D Mackay and M Blyth. Also present were P&K Cllrs M Barnacle and G Hayton, Mrs M Scott (Min Secy), Sergeant Wilson, PC Child and five members of the public. Apologies were received from CCllrs P Zarb and I Jack, and from CCllr Thomas who, due to a prior commitment, arrived towards the end of the meeting.

### **Police Report**

PC Child introduced Sgt Wilson.

There have been a number of crimes in relation to cars, involving break-in and stealing from cars and the theft of vehicles. From information received from a member of the public, a person has been arrested, charged and held responsible for a total of nine incidents. The Police are grateful for any information received from the public and ask that any suspicious behaviour be reported to them as early detection can prevent crimes taking place.

The Police now have the use of two cycles. Certain locations, which previously had to be accessed on foot, can now be reached more quickly.

CCllr Drummond commended the Police on their prompt response (within seven minutes) to an incident at the Millbridge Hall during the Art Club Exhibition, when a fight broke out in the vicinity of the hall. PC Child advised that one or two people were charged in relation to this incident.

Cllr Barnacle questioned the publication of Safety Mobile Camera locations. Sgt Wilson explained that making people aware of the siting of these cameras was in an effort to prevent accidents on certain roads where speeding has been recognized and the public have raised concerns in this regard.

On behal f of the CC, the Chairman thanked the officers who were on duty during both the Remembrance Day Parade and Light Up Kinross for their assistance at these events. He also thanked the representatives for their attendance this evening and wished them well for 2007.

### **Matters Arising**

**ABI Action Plan**: CCllr Cuthbert will represent the CC at the Steering Group, first meeting on 18 December.

Golfball: Cllr Barnacle advised that the site has not yet changed hands. The glare has not been reduced significantly. The lighting is required for security reasons. The Chairman suggested that if the screen had been replaced at the time of damage, this problem would not have arisen.

#### Planning Matters

Planning Applications: The CC raised no comments on the following: Installation of a single 0.3m diameter transmission dish to existing mast at the Green Hotel (06/02406/FUL); Erection of a steel storage container at Costcutter Supermarket, Green Road (0602199/FUL); Erection of a dwelling house at gap site at Myre Terrace (06/0244/FUL); various applications for alterations to domestic properties.

Tillyrie Wind Cluster: A large document was available for

perusal in relation to the proposed installation (a resubmission of an earlier application) of five wind turbines in the hills north of Milnathort. To be discussed at the January meeting.

### Report from Perth & Kinross Councillors

Structure Plan Population and Housing Projections: A copy of a letter written by Cllr Barnacle to the Chief Executive of P&KC was circulated to the CC members prior to the meeting. In this letter Cllr Barnacle summarised the issues raised by those attending a recent meeting with regard to the Structure Plan Population and Housing Projections and other related matters and highlighted concerns regarding the reference in the Local Plan to a 25% increase in housing population. The letter also mentions the concerns expressed regarding the continuing loss of land zoned for industrial development in Kinross-shire to housing and the scarcity of land to accommodate offices and small workshops. It was agreed the CC would write to P&KC endorsing Cllr Barnacle's letter.

**Balado Quarry Site**: CCllr Barnacle reported that liaison is to take place between residents, P&KC, landowner, developer etc. A number of issues have been raised, such as road silage and private water supply.

**A977**: It was confirmed that the widening of this roadway was included as a condition in the recent negotiations.

Cllr Hayton reported on various matters and issues that have arisen since the last CC meeting.

He advised that an ongoing refurbishment of **council housing** was taking place.

A request has been made to P&KC for an additional **footpath** in the Green Park area. A map is required detailing the exact location for this pathway.

Two footpaths are also required to the rear of **Millbridge** car park, adjacent to the Housing Association development, the old paths having been fenced off during construction of the housing estate.

**Station Road**: The situation with the rainwater is still an ongoing problem and permission is required to run this into a drainage system (soak away). However, Scottish Water do not have funding for this facility.

The Swansacre building is still under negotiation.

**Sandport Mews**: It was noted that properties are being advertised for sale in Sandport Mews. The Chairman questioned whether this address was official. It was confirmed that the Council did not pass this.

Cllr Hayton advised that four **street names** are required for the G S Brown Development. To be discussed at next meeting.

It was noted that the **pathway** down to the new Cleish Road is on the west side of the road (not east side as planned).

Approval has been received from the Executive for the **Kinross-shire sign** on the motorway.

CClr Blyth mentioned that a member of the public had advised that there are no **baby swings** at Davies Park. It was commented that parties unknown removed these.

**Green Road**: CCllr Mackay questioned whether work was currently being carried out by the Council in this area. The Cllrs were unable to confirm this.

Cllr Blyth raised the matter of **dog fouling** in public parks

and footpaths. A suggestion was made that we request the services of the Dog Warden; people have in the past been fined for allowing dog fouling in Kinross. Mention was made of the broken dog bin the park. Cllr Barnacle will follow this up. New notices are also to be displayed.

High School: Negotiations are still ongoing.

#### Correspondence

**Resignation**: A communication was received from Brian West intimating his resignation from the CC due to increasing work commitments.

**Kirkgate Park**: A letter and accompanying plans were received regarding the proposed development. Funding is in place for Phase I which, it is hoped, will be completed by June 2007. Fundraising is still ongoing. **Gateway**: CCllr Cuthbert, as a representative of Kinross in Bloom, advised those present of the planned Gateway Entrance to Kinross. This would be erected in the grass triangle at the approach to the motorway and plans were available for perusal. A planning application would be submitted.

Trees: CCllr Cuthbert advised those present of Kinross in Bloom's proposal to plant trees in certain areas of Kinross, to include 120 trees around Myre Park to act as a screen between the residential areas and the industrial areas; replacement of two trees lost through vandalism in Gacé Gardens, six flowering pears to be planted in the piece of ground on Springfield Road between Argyll Road and Whinfield Drive; a number of trees are proposed for Davies Park; three spring flowering trees in the North Cemetery and four on the Sunnypark side; seven trees in Lathro Park and at site of Leisure Pool to be replaced. CCllr Colliar raised objections regarding the planting of trees at Springfield Road/Whinfield due to safety issues, i.e. sight lines for traffic. In this case it would be necessary to examine a detailed plan to confirm the position in relation to the concerns expressed. The Chairman also questioned whether it would be possible to replace the damaged uprooted trees at Argyll Road/Sutherland Drive. CCllr Cuthbert replied that the advice he received was that they could not plant in this area as the Council were unable to confirm the location of the services, however he offered to check into this again.

### **Christmas Lights**

Complaints have been received from members of the public regarding the condition of the Christmas lights. It was explained that an electrician was engaged to check over the units, however the Council erected the lights before this service was delivered. CCllr McConnell reported that a two-day repair would be carried out the following week and certain bulbs would be replaced. The lights were operating satisfactorily prior to dismantle last year and it may be either in the removal or erection that the damage is sustained. It was also commented that since the closure of the Town Hall it has been necessary to relocate the "switch on" to the Council Offices.

### **Town Hall**

A lengthy discussion was held on this subject. CCllr Cuthbert updated those present on the current position.

The Legal Department of the Council, having now perused the Opinion, have offered a figure of£185,000 which after certain deductions would be lodged in the Common Good Fund for Kinross and utilised solely for the benefit of the people of Kinross, providing grants to voluntary organisations, such as Christmas Lights etc. The Q.C.'s fee for the Opinion and other costs would be deducted from the

figure of £185,000.00. It was also noted that missives of sale have been concluded for the Town Hall. However, the campaign at the outset was twofold, (One) to stop the sale of the buildings solely for housing development and (Two) to ensure that any sale proceeds were placed in the Common Good Fund for the Town. This latter directive has been achieved, however it was hoped that the Town Hall would remain as a focus for the centre of the Town and could be utilised as a Community Hall, with possible development of the Library and Social Work Office into flats or offices.

Cllr Hayton advised that funding would not be available from the Council Budget for a project of this size and level, i.e the repair and annual maintenance of the Hall to bring it up to a reasonable standard.

Those present were reminded that over 2,000 people signed the Petition and also a number of local people who approached the Authorities direct are also being represented by the Town Hall Committee. Their interests have to be taken into account in this matter. It was noted that should the Council proposal be accepted, the CC would have no control over the monies held in the Common Good Fund which would be administered by a Committee comprising Council Members and Local Members.

The Town Hall Sub-Committee have to reach a decision on whether to proceed with this case, appoint a Reporter to check whether the buildings can be alienated or not, and thereafter leave the decision in the hands of the Sheriff, or whether to accept the proposal now received from the Council and bring this matter to an end.

The Committee Council agreed to fully support the Sub-Committee on the decision reached by them in this matter.

### **NHS Dentistry Campaign**

CCllr Thomas advised that the local group were lodging their Petition to the Scottish Parliament.

### **News from the January Meeting**

Present at the meeting held on 10 January in the Green Hotel were: CCllrs D Colliar (Chair), D Cuthbert, E Thomas, C Drummond, D Mackay and P Zarb. Also in attendance were P&K Cllrs W Robertson and G Hayton; Mrs M Scott (Min Secy); PC Child and 14 members of the public. The Chairman opened the meeting by welcoming those present and conveying best wishes to all for 2007 and advised that the CC would continue with their efforts in representing the community of Kinross throughout this coming year. Apologies for absence were received from CCllrs R McConnell, M Blyth and I Jack and from P&K Cllr M Barnacle.

**Police Report**: PC Child advised that the festive season proved quiet. However, it was noted that persons were apprehended in relation to recent damage sustained to windows in the High Street and Avenue Road.

**Entrance to Kirkgate Park**: It was reported that the Council have added the repair of the hole in this road to their Phase I Path Improvements.

#### Wind Cluster at Tillyrie

The Chairman advised that letters of objection have been received by the CC in relation to this proposed development and he informed those present of their content. The main points of argument are the visual impact on Kinross and Milnathort, the effect this will have in relation to the water supply and drainage in the area and the flight of geese. It was noted that Loch Leven Special Protection areas might also be affected if this proposal goes ahead.

Mr P Hessey, the owner of a property in the close vicinity of the site, addressed those present. He advised that the turbines would be around 70/75 metres in height and will be seen from areas in Kinross. The grounds for objection include the effect this development will have on tourism, the disruption and noise, the impact on water (both public and private), the Special Protection Areas and the flight of geese. He asked if the CC would support his objection on these stated grounds.

A second member of the public also reiterated the point that the water supply will be affected. He explained that in his own case the access tracks pass by near to both the pipes and spring. No guarantees are to be given in relation to the water supply, indeed the proviso is that should any party have concerns in this regard it will be up to them to prove that the proposal will have a detrimental effect on the water supply to their property. It was noted that drainage may also be affected.

The Kinross Area Local Plan states the area as being of great landscape value.

Mrs Thomson from Tillyrie Farm then addressed the meeting. Environmental and Hydrology Reports have been produced and SEPA and Scottish Water have raised no objections. It was noted that the water is to be tested before the commencement of the works, during construction and again after completion. Mrs Thomson assured those present that the proposal is low risk and should have no detrimental affect on the water supply. A noise assessment has also been documented. She advised that a survey of the visibility areas was conducted, i.e. a street walk around Milnathort etc. and a minimum number of houses would be affected by this development. The roadway is an existing hard track and will be upgraded and widened. A bird study has also been conducted and RSPB consulted.

After discussion and comments from the CC members it was agreed that we should raise objections in relation to the visual impact on Kinross, and express our concerns in relation to the provision of the water supply to these householders. It was noted that an assurance that the water supply will be protected would be a requisite and should be covered in the Section 75 Agreement.

**G S Brown House Names**: The CC have been asked to put forward four suggested street names for the development near Somerfield. Cllr Hayton advised that Clashburn Road would be the title of the main road in this Development. After discussion it was agreed that names linked to the old Railway line in Kinross would be appropriate. The Chairman suggested Junction Road and it was further suggested that this should be the name of the main road. The CC will give consideration to this and the matter will be added to the Agenda for discussion at the next meeting.

**Hatchbank Farm Development**: The CC received a letter objecting to this housing development. As this is a recent application and not yet registered, it was agreed that this matter be left in abeyance until the next CC meeting.

Kinross Town Hall: The current situation is that the matter is to be referred back to Court, a Reporter will be appointed who will prepare a brief to be presented to the Sheriff Cllr Hayton advised that the maintenance of the building would be paid for from the Common Good Fund. Cllr Hayton advised that the property is in a dilapidated state, in need of total overhaul. He explained that that the monetary figure mentioned some years ago of £400,000 was to repair the building to an occupational standard, not to develop or

upgrade the building. He stated that it would not be economical to utilise this building as a Community Hall.

**Election sub committee**: An election may be necessary in April and in this connection a sub-committee was formed to organise and run same consisting of the Chairman, CCllrs Drummond and Thomas. Any other CC members can offer assistance if available.

### Report from P&K Councillors

**Dentistry**: Cllr Robertson advised that 85 people contacted him direct in relation to the lack of NHS Dentistry in Kinross. He has passed on their details to a representative from NHS Tayside, Primary Care Services, who will write to each party and endeavour to find an NHS dentist for all.

**Flooding**: Cllr Robertson referred to the recent devastation in Milnathort. If anyone in Kinross was affected by the flooding over 13/14 December, can they please contact any of the Cllrs (Robertson, Hayton or Barnacle) with the details.

**Advertising**: If a board is bigger than 2 sq m, Planning Consent is required.

**Budget**: The budget for Adult Care in the Home is currently being reviewed. Both Cllrs addressed this subject and explained that due to cuts it would be difficult to maintain an adequate service. It was noted that 1% of the Council Tax brings in around £670,000.

**Special Needs School in Perth**: Cllr Hayton advised that work has commenced on this site and pointed out that some of Kinross children will attend this School.

**Kinross School**: The new School is to be known as Kinross High School. The site will be known as Loch Leven Community Campus.

### General Correspondence

**Mortuary**: Communication requesting completion and return of Lease document. The Chairman is to remind CCllr McConnell of this matter.

Minutes of the **Convention** of Perth and Kinross Community Councils. Their next meeting is scheduled for 25 March 2007.

### Other Business

CCllr Drummond enquired if a date was fixed for beginning construction on the new School. Cllr Hayton's response was no to this question.

It was remarked that a number of shops are displaying advertising boards on the pavement and, as a result, it is difficult to walk past these areas. Cllr Hayton will approach the various parties in this regard.

The next meeting of Kinross CC will take place on Wednesday 7 February at 7.30pm in the Masonic Hall.

### Milnathort Community Council News from the January Meeting

A meeting was held on 11 January 2007 in Milnathort Primary School. CCllr Giacopazzi, Chairman, welcomed CCllrs Thomson, Bennet, Porter, Ross, and Cottingham, as well as extending a welcome to CCllr Sandy Smith, who was attending his first CC meeting. Also in attendance were P&K Cllr W Robertson, Minute Secretary E Rougvie, two members of Tayside Police and 22 members of the public. CCllr Giacopazzi began by explaining that the December

CCllr Giacopazzi began by explaining that the December meeting had not taken place because the flooding had meant that no janitorial cover was available for the school. The minutes of the November meeting were proposed by CCllr Ross and seconded by CCllr Porter.

Police matters: PC Marissa Hardie reported that December had seen a spate of car thefts and break-ins, and a man had been detained in custody for these offences. On the matter of one of the cars being burnt out and left outside the church, she explained that it was the insurers' responsibility to move the vehicle, but for reasons she could not divulge, this had not happened on this occasion. However, despite being under no obligation to do so, the police had moved the car because a PC Hardie said that over wedding was taking place. Christmas the Safer Scotland and Drink Driving campaigns had been run, in addition to road and speed checks, and foot patrols. No drunk drivers were reported. She told the meeting that there had been a number of the fts of diesel and heating oil, and she urged those who had tanks to ensure that they were as secure as possible.

Milnathort floods: CCllr Giacopazzi told the meeting that until such time as a preliminary report was received into the cause of the floods of December 13 there was little that could be said in terms of who took responsibility. He, P&K Cllr Robertson and several people who had been affected had had a meeting with George Reid MSP, who was pursuing the matter at the highest possible level on behalf of the village, and was calling for an independent review of the flood protection scheme. A meeting was also due to be held between the Chief Executive of P&KC and the Chief Executive of Arup, who designed the scheme. A discussion followed, during which P&K Cllr Robertson said that he was to attend a meeting of P&KC's Environment and In frastructure Committee, at which other issues relating to the flooding would be raised. He had also spoken to the Director of Transport and Planning, who had assured him that sensitivity would be used in terms of future building.

### Planning: Tillyrie Wind Cluster application

At this point, CCllr Thomson joined the members of the public. CCllr Cottingham gave an outline of the proposed wind farm at Tillyrie Farm submitted by John Lawrie. He

said it involved five wind turbines, each with a capacity of 850kw, producing 13,000 mgw of electricity per year to serve 2700 homes. The hubs would measure 49 metres and the masts would be a maximum height of 75 metres. Access for trucks would be a well-made road to the north of Milnathort. It was planned for the site to last for 25 years, after which it would be dismantled and removed.

CCIIr Giacopazzi said that he had received 150 letters about the application: 25 letters of support had come from within Area 49; 21 from Kinross-shire and 90 from other areas. There were four letters of objection from outwith Area 49 and four from within Area 49. Mr Peter Hessey spoke to a letter he had written in which he outlined his objections on the grounds of two main areas: the impact on the landscape and visual amenity and the effect on water supplies. He questioned the effectiveness of the windmills in terms of producing electricity, and expressed concern about the impact on wildlife such as geese and osprey.

CCllr Giacopazzi read out a letter of support for the proposed development, which said it was the smallest in the Ochils; there would be little visual impact; it was remotely situated and unique in that it was being developed by a local farming family. Mr Steve Makin, consultant for the project, then outlined the history of the application, which had been turned down in 2005 when it was first considered. Since then, concerns raised by SNH and P&KC had been addressed by reducing the height of the turbines and relocating them, and a hydrological assessment had taken place which concluded that the risk to local water supplies was extremely low. The construction period was very short and would involve a low level of disruption. Mrs Dorothy Thomson assured those who had expressed their concerns about the effect on their water supply that the issue was being taken very seriously and that monitoring would take place before, during and after construction should the application be approved. In addition, they would be prepared to enter into a Section 75 Agreement, whereby if the application was successful the water supplies would be continually monitored and action taken should any problems arise.

After further discussion, CCllrs put forward their own views and the following motion was carried: 'MCC does not object to the application for a wind cluster at Tillyrie, providing the applicant enters into a legally binding agreement that he shall restore any private water supply adversely affected by the works to its original standard, at his expense. Such obligation should be enforced by conditions in the granting of permission by the Planning Authority.'

Correspondence: CCllr Bennet read a letter from the Countryside Alliance urging people to help save local Post Offices, whose future they claim is under threat. They are asked to write with their views about the importance of their local Post Office to: Jim Fitzpatrick MP, Parliamentary Under Secretary of State for Employment Relations and Postal Services, Department of Trade and Industry, 1 Victoria Street, London SW1H OET.

AOB: P&K Cllr Robertson reported that the barrier in Burleigh Road was to be extended; that BEAR Scotland had a budget to repair the safety barriers on the motorway, and that a path at Burleigh Castle would be completed during this financial year. It was hoped that the path would go through the castle itself, but Historic Scotland had objected to this. He also agreed to accompany CCllr Porter to see damaged walls in the village and a fence that had been knocked down behind the school.

The next meeting of the CC will take place in Milnathort Primary School on Thursday 8 February at 7.30pm.

### News from the January Meeting

The meeting on 8 January 2007 should have taken place in the booked and advertised venue of Blairingone School; unfortunately access could not be gained and the meeting took place late thanks to a very supportive landlord in The Stables in Crook of Devon. CCllrs I Booth (Chair), R Dalton, A Chappell and F Watt were present. Also in attendance were PC Child and six members of the public. Apologies were received from S Sharp (resigned), C Danks, G Pease and P&K Cllr M Barnacle.

**Police matters**: Regarding speeding on Vicar's Bridge Road, a letter from Chic Haggart (Traffic & Road Safety manager P&KC) advises that a detailed examination of road layout and accident data will be carried out and the CC to be "kept advised of the outcome."

**Devonshaw Quarry**: Further letter sent to Environment Service re identification of current owner and reply awaited. **Footways for Lendrickmuir Road**: Letter sent to Environment Service with request for consideration of provision of footways.

**Safety Camera on A977**: Letter from Tayside police/Safety Camera Partnership. Must be seen, must be aware, used as entering a dangerous stretch of road, re accident analysis statistics.

### **Community Policing**

PC Child highlighted the benefits gained over the festive period of the new police shift pattern, which gives a better deployment of manpower at potentially critical hours.

He was questioned on the need for riders to be visible, highlighting the danger of the dark horse ridden by a rider in dark clothes on a very dull day. Several people agreed that this was cause for concern, on both minor and relatively major roads within the Fossoway area. This problem will be highlighted in Police Box in the next newsletter, to assist in the prevention of avoidable accidents.

### Perth & Kinross Council Business

CCllr Chappell substituting for P&K Cllr Barnacle:

**Devonshaw Quarry**: Cllr. Barnacle has again spoken with Jim Dawson (Environment Service). Responsibility for the quarry and its surroundings rests with the owner. Mr Dawson continues to pursue his enquiry with the Land Registry

**Dog Bins, Blairingone**: Tom Brydon (P&KC) has 'toured' Blairingone, investigating the dog bin situation. He does not propose to add a further dog bin. However, he has identified three areas requiring 'signage'. It appears that the dog bins are not being used and Mr Brydon has detected incidents of fouling. If a resident knows of any individual who permits their dog to foul and is willing to advise P&KC staff of the name of the individual in absolute confidence, then the offending individual will be visited by P&KC officials.

**Dog Bins, Powmill** and Crook of Devon: There is a possibility that a dog bin will be provided in Powmill and at the Primary School in Crook of Devon.

Bridle Way/Foot Path: Cllr Barnacle met with Mrs Turnbull regarding the proposed bridle way/foot path adjoining her land. Cllr Barnacle shares some of Mrs Turnbull's concerns. Cllr Barnacle proposes that Mrs Turnbull and Mrs Brown meet on site with the area Planning Officer with a view to resolving the difficulties. Cllr Barnacle suggests that Fossoway CC submits a 'holding objection' to the application for formation of the

bridle way, pending resolution of the difficulties.

**Housing Growth in Kinross-shire**: Cllr Barnacle wishes to remind the CC if they wish to provide a view on his letter regarding future Kinross-shire Housing Growth, which was sent to the P&KC Chief Executive, Bernadette Malone, in November last year.

### Planning Matters

The CC had no objections to the following applications: 06/02473/FUL Muirhead Farm, Blairingone (an agricultural worker's house); 06/02727/OUT Crook of Devon House, Main Street, Crook of Devon (two house development within current village boundary); 06/02575/FUL Units 3 & 4, The Coach House, Rumbling Bridge.

06/02516/FUL Land to east of Carnbo village: with the status of Hallhill steading now clarified (no longer a farm steading) but two domestic dwellings this application is for a newly classified gap site. Nine letters of support from the village have been received. No objections from the CC.

06/01995/FUL Bridleway at Broomhill Cottage, Drum: the CC will send a letter requesting a "holding objection" until a site meeting can be organised.

06/02617/FUL Church Conversion, Blairingone: no objections from the CC; however, local residents have objected primarily on the grounds of access.

0602345/OUT Four dwelling houses on land at Rumbling Bridge Nursing Home: The CC objecting on the following grounds: a) against KALP Policy 91, b) Village amenity site, especially with Gorge, c) Restrict garden ground available to residents, and diminish the quality of the setting of the nursing Home.

### **General Correspondence**

The CC has received a number of letters from Carnbo residents (nine homes) in support of Mr & Mrs Drysdale's proposals for a single dwelling house in Carnbo village.

### Other Business

An appeal is being made for new CC members; several members are due to step down, some have resigned already, and some were only co-opted on till February 2007 to fill gaps created by the aforementioned. It is in everybody's interests to be Community Aware and one of the easiest, pro-active ways is to become a Community Councillor. Interested individuals should in the first instance contact Isabel Booth (Chair) on 01259 742 524.

Member of the public raised the question of the CC representation on the Board of "The Hollies" School, and the need for representation or not on various other entities; this matter will be looked into and the duties of the Community Councillors clarified for the next meeting in February.

CCIIr Dalton gave a brief summary of the CC's current finances. It was noted that while still expected accounts to be met until next P&KC grant in May 07, there were sufficient funds to allocate a £135 grant to Carnbo Hall. This allocation was agreed by the CC.

The next meeting of Fossoway and District CC will take place at Crook of Devon Church Hall on Monday 5 February at 7.30pm.

### **News from the December Meeting**

The Community Council met in the Tabernacle Hall, Blairadam on Monday 11 December and was attended by all six CCllrs, P&K Cllr M Barnacle, PC Child, the C&B newsletter editor and 20 members of the public.

Crime Prevention: PC Child, in place of PC Pedersen, said there was little to report, as there had been no incidents of housebreaking in the area. Valiant Roadchecks were continuing and the Festive Road Safety Campaign would be in operation. This is also an opportunity to remind everyone to be vigilant with their home security, making sure that doors are firmly locked, sheds kept safe, and a light kept switched on whenever you are out.

Wind Farms: There is now a further application for 5 wind turbines at Tillyrie; this is additional to the applications already received. It was pointed out that it is difficult for most members of the community to appraise each application as not all the information was readily available. Cllr Barnacle said that the Public Enquiry beginning on 27 February would not include the revised Tillyrie application. After discussion it was agreed that the CC should write to P&KC with the view that the application was premature and that a decision should await the outcome of the Public Enquiry.

**Tracks and Trails:** Work on the walk around Loch Leven has now begun. Perhaps in the future our Tracks and Trails might have a link-up.

#### Planning

Shepherd's Neuk and Stable Block: The Secy will look at the plan and note the size of the proposed feed store.

Land to north of Greenacres: There is a proposed extension from 4 sites by a further 4 sites; work seems to be going on despite no permission having been given. It would appear that once again there has been a breach of the planning regulations The CC have asked for a proper development plan, but this request has been ignored. The CC will write to the Council in the strongest possible terms saying that a proper plan should be delivered and that the Council should define a boundary before any development is approved.

Nivingston House: An application has been lodged for development of 16 houses, 7 in the garden and a further 9 outside, over two phases. It was proposed that this application be rejected on the following grounds: density, effect on surroundings, the scale (too big), access to the site, the design which is suburban, totally unsuited to a rural landscape, and the impact on the school and the village. Other points raised were that such a development would be on the edge of an AGLV, the surrounding roads really cannot take any more traffic, and utilities such as electricity and water are already under pressure. There is no doubt that there is a strong feeling in the Community against such a development. The CC will write to the Council with their objections. All those with views about this application should write to the Director of Planning with copy letters to Cllr Barnacle (this is most important).

Further observations were that the Flockhouse and Sunnyside developments would also have impacts.

West Mains Farm and Binn Cottage: These applications are to be reconsidered as planning permission was refused under delegated powers and the applications should have gone to Committee.

Flockhouse (Caravan): Permission has not yet been granted;

this applications is pending as is that for the steading development. At Flockhouse Farm, application for the demolition of the outbuildings and for 7 new houses has been withdrawn.

Sunnyside: Further information is sought

Templeton: New application for one house submitted.

Kinnaird: No decision as yet.

Housing in the Countryside: The Chairman reported that he had attended a meeting in Kinross organised by Cllr Barnacle; this was attended by representatives of all the CCs and Cllr Robertson. A letter had been drafted from all those attending, expressing concerns on the housing increase in Kinross-shire, of which this is just a summary. There is deep concern at the implementation of the present housing policy and the development of brown field sites. Small steading developments are all right but large housing developments are not. The other concern was the question of affordable housing. The possibility of a 20 year strategy plan should be considered The CC would write and endorse this letter. Cllr Barnacle reported that this letter has now been sent to the Chief Executive

**Modernisation of the Planning System:** It was suggested that the CC might have a presentation, hopefully from Peter Marshall, at either of our February or March meetings.

Roads: Various points were raised, namely the finish on the Blairforge pathway, mud on the road from Middleton Park, the lights at Middleton Park which have still not been changed despite assurances from the developer, the desirability of better signage at the Kinnaird Bends, the poor quality of the signs at Cleish Mill Bends (contrary to belief they were not blown off, they just fell off), better signage at Carsegour. There is also the matter of mud on the roads, but this is a difficult problem at this time of year.

**Grant to Community Council:** This had now been received.

**Dates of Community Council Meetings:** The following dates have now been confirmed: 19 February, Cleish; 19 March, Tabernacle, Blairadam; 14 May, Cleish; 25 June, Tabernacle, Blairadam; 27 August, Cleish; 27 October, Tabernacle, Blairadam; 10 December, Cleish.

The next meeting of Cleish & Blairadam CC will take place on Monday 19 February at 7.30pm in Cleish Village Hall.

### Portmoak Community Council

### News from the December meeting

A meeting was held on Tuesday 12 December 2006 at Portmoak Primary School. In attendance were Wendy MacPhedran (Chairwoman), Sue Mitchell-Henry, Bob Drysdale, Jim Shepherd, Alistair Smith, P&K Cllr Mike Barnacle, WPC Hardie and several members of the public.

### Police Report

The Police are advising everyone to make sure that their fuel oil is securely locked against the ft. In Perthshire there have been instances of break-ins to houses, stealing car keys for high value cars and stealing them.

### Secretary's Report

**Kinross Gateway Sign**: The Secy had received drawings from Kinross in Bloom showing their proposals for sign just off Junction 6 on the M90. The CC was in agreement with the proposals.

Mrs Clydesdale Bench: The Secy was pleased to report that P&KC Roads had repositioned the bench and this was very satisfactory. He has written to P&KC thanking them. There is a plaque which can now be positioned on the bench dedicated to Mrs Clydesdale.

### Paths Group

The Chairwoman reported on her meetings with the Farm and Wildlife Advisory Group regarding the land being offered by Stephens. They will prepare a report on the possibilities of management and the provision of such things as a viewpoint and forward it to the CC.

The Secy explained the background to the Stephens land. Stephens have to prepare a landscape management plan as part of their planning application. They approached the CC with a view to obtaining the community's cooperation and also to handing over the ownership to the community. The Chairwoman had a meeting in Edinburgh with the Development Trust Association of Scotland to obtain advice as to how the CC could proceed to set up a system to obtain the ownership of the land. Essentially, the CC would create a Trust, which would be separate from the CC with a Board of Trustees, one of whom could be a CCllr. The CC proposed to have a separate public meeting to explain all this to the Community in January.

Niall Lobley, P&KC Senior Ranger, explained at the last Paths Group meeting it was agreed that the Tetley Trail be re-branded the Michael Bruce Trail. The local Primary School is being asked to help with the production of suitable path signs.

They were also looking at the raising of funds for the updating and provisions of paths in the area, in particular the Path up the side of the Bishophill Golf Course and for the future maintenance of the Stephen's land.

Callum Robertson, Balneathill Farm, read a letter from his solicitor, informing him that P&KC understood that he no longer wished to proceed with the Land Agreement for the Tetley Trail passing through his land. The CC had understood that following Mr Robertson concluding a Land Management plan with Scottish Executive, that the Land Agreement was no longer required by Mr Robertson. Mr Robertson confirmed that he still wished an Agreement. The Secy will write to the CC's lawyer.

### Kinross-shire Fund

CCIIr Drysdale reported on the last meeting at which the priorities were looked at. The next meeting will be on 12 March 2007.

#### A911

Cllr Barnacle had spoken to Jillian Grey, P&KC, who had apologised for the delay in replying to the CC's letter of August. There is a major review of road speed being conducted in the UK and this may influence the P&KC response. Cllr Barnacle has set up a meeting with Ms Gray for 21 December, on site, to discuss the increased traffic using the Dryside Road now that it has been hard surfaced.

### **Planning Matters**

06/02111/FUL Installation of a wood burning stove and flue, Inis Bheatha, Back Dykes Road, Kinnesswood: No comment.

06/02231/FUL Erection of a conservatory, 3 Loch Leven Court, Wester Balgedie: No comment.

06/02251/OUT Proposed residential development involving conversion of steading buildings (in outline), Grahamstone Farm, Kinnesswood: The CC agreed to object strongly to this application as no details have been provided for the development and the land area proposed seems to extend into green field areas.

06/02472/FUL Erection of five wind turbines etc, land at Tillyrie Farm, Milnathort. The CC agreed to write that this application should be considered along with the four other applications, which are part of a Public Local Inquiry at the moment. The CC felt that this application came nearest to the Guidelines of P&KC and therefore for that reason would prefer it to all the others. However, it would not wish to see consent given to Tillyrie and also to one of the others being considered by the PLI.

Proposed Amendments to Structure Plan, amended Housing in the Countryside Plan and Affordable Housing Cllr Barnacle had forwarded a draft letter to the Chief Executive regarding these matters. The CC had amended and added to the letter, which strongly supported the opposition to these Planning Proposals by P&KC and that they should be urgently re-considered.

### Cllr Barnacle

Cllr Barnacle reported on a meeting with Sue Allan of P&KC Outdoor Services on future works to the play area at Kinnesswood, following consultation with the school children.

There have been complaints that the new Bus Loop is not working, but Cllr Barnacle pointed out that the work is not yet complete.

Cllr Barnacle had received a briefing note on Fly-tipping, which at present is under SEPA. This is being discussed and complaints are being monitored. A new facility for waste is about to be created at Turfhills for Kinross-shire and it is hoped this will be much better than the present facilities.

Cllr Barnacle had received complaints about the road markings and lack of cat's eyes on the South loch road. He had discussed this with Stuart D'All, P&KC Roads.

A meeting of Portmoak CC was due to have taken place on 9 January.

The next meeting of Portmoak CC will take place on Tuesday 13 February.
